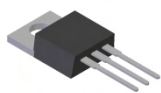

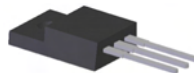

Top View



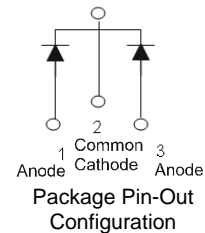
