1. General description

AC Thyristor Triac power switch in a SOT404 (D2PAK) surface mountable plastic package with self-protective clamping capabilities against low and high energy transients. This "series CT" triac will commutate the full RMS current at the maximum rated junction temperature ($T_{j(max)}$ = 150 °C) without the aid of a snubber. It is used in applications where "high junction operating temperature capability" is required.




Fig. 1. RMS on-state current as a function of mounting base temperature; maximum values




Fig. 2. RMS on-state current as a function of surge duration; maximum values




Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values




Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values




Fig. 5. Non-repetitive peak on-state current as a function of pulse width; maximum values




Fig. 6. Test circuit for inductive and resistive loads with conditions equivalent to IEC 61000-4-5




Fig. 7. Transient thermal impedance from junction to mounting base as a function of pulse width




Fig. 8. Normalized gate trigger current as a function of junction temperature




Fig. 10. Normalized holding current as a function of junction temperature





Fig. 9. Normalized latching current as a function of junction temperature






