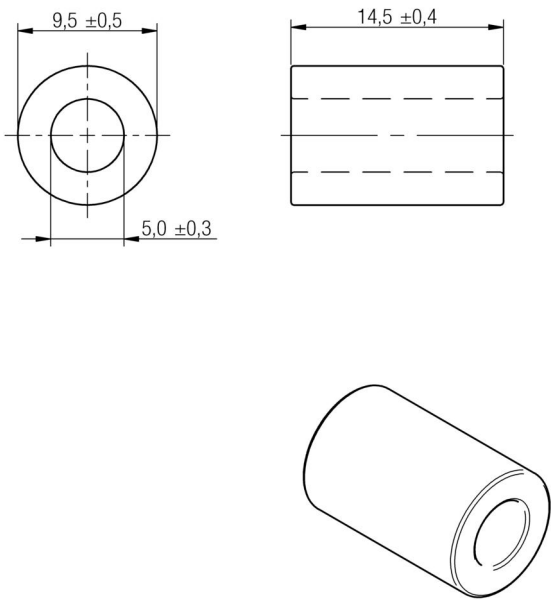

Accordingly to this the product is exposed to the pressure of the molding material with the effect that the ferrite body is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endanger to be affected. After the molding material is cured, the ferrite body of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

The responsibility for the applicability of customer specific products and use in a particular customer design is always within the authority of the customer. All technical specifications for standard products do also apply for customer specific products.

Cleaning agents that are used to clean the application might damage or change the characteristics of the component or body.



Direct mechanical impact to the product shall be prevented as the ferrite material of the ferrite body could flake or in the worst case it could break.

The approach named above does not apply in the case of individual agreements deviating from the foregoing for customer-specific products.


