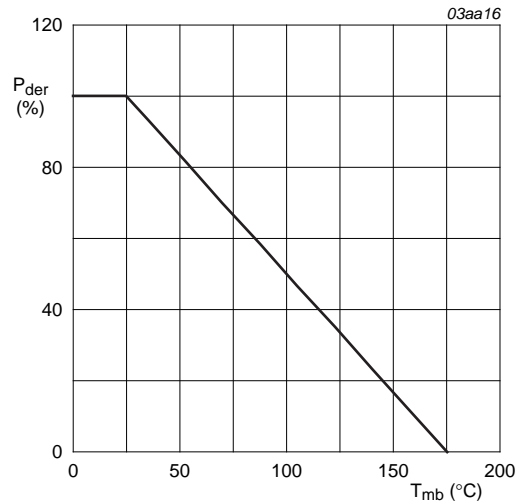

Fig 2. Normalized total power dissipation as a function of mounting base temperature

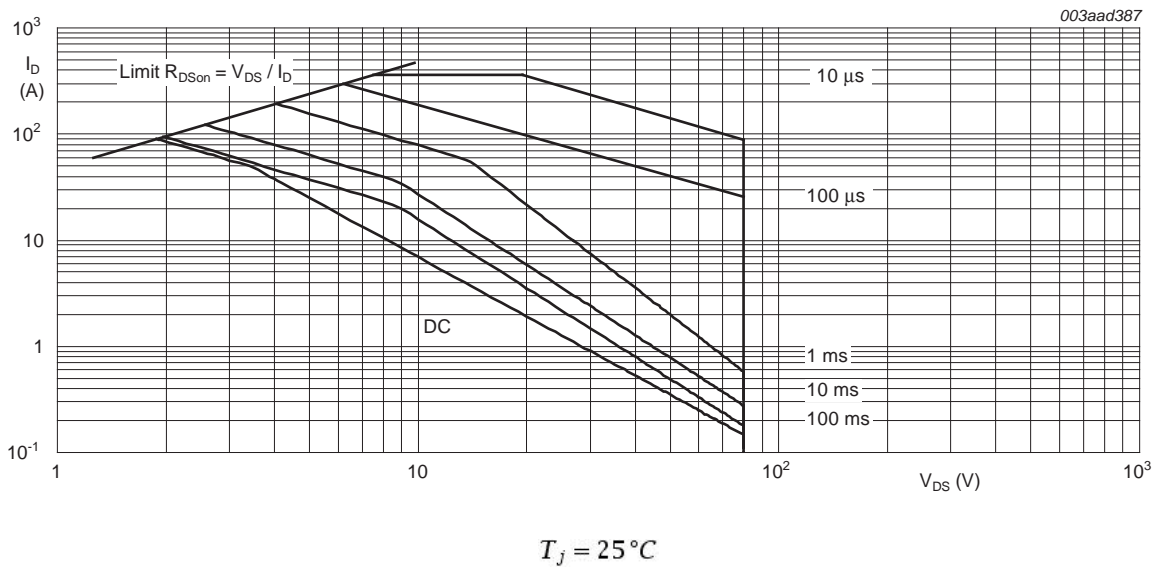
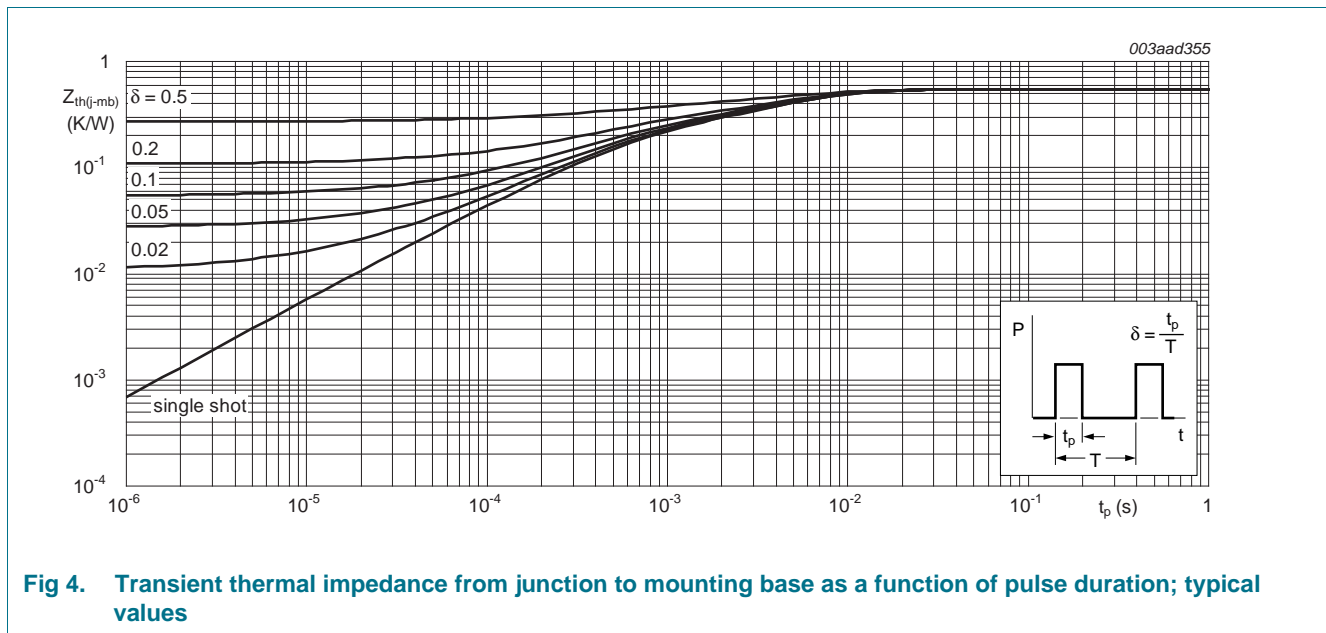


Fig 3. Safe operating area; continuous and peak drain currents as a function of drain-source voltage

**Fig 4. Transient thermal impedance from junction to mounting base as a function of pulse duration; typical values**

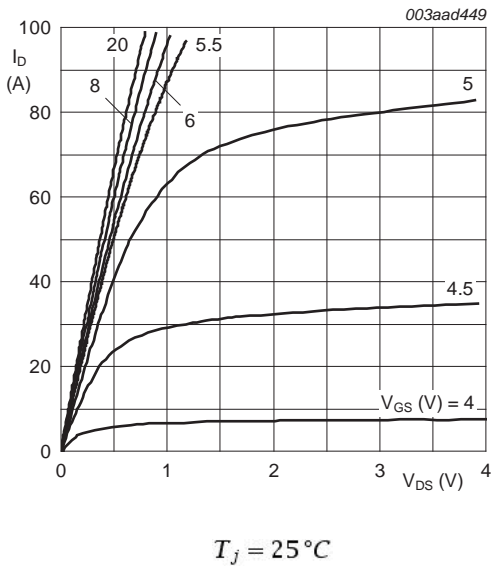

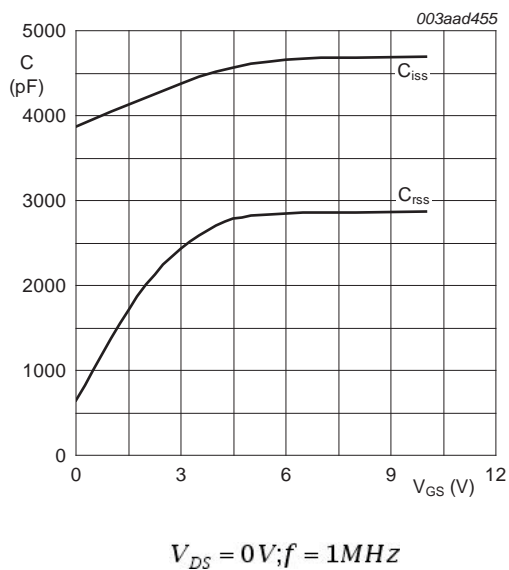

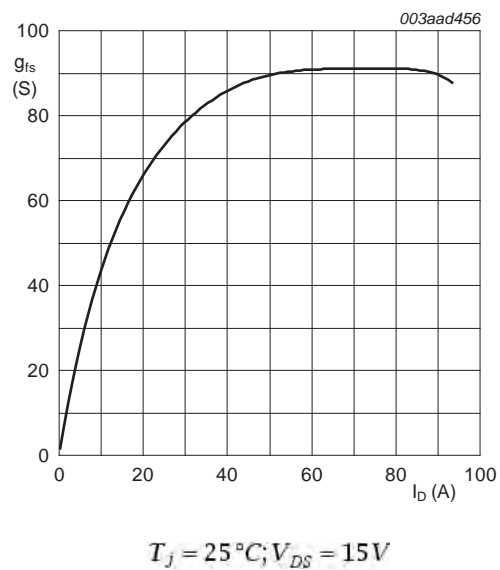
**Fig 5. Output characteristics: drain current as a function of drain-source voltage; typical values**



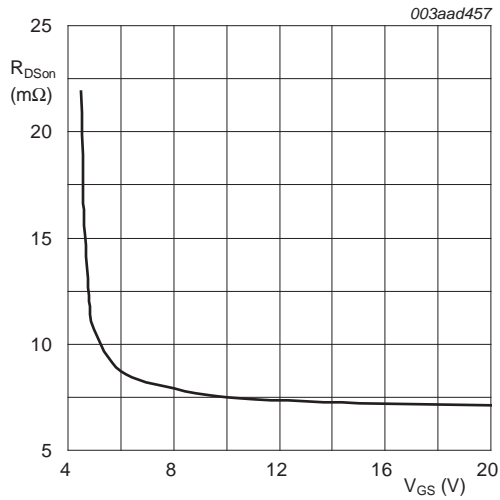
**Fig 6. Transfer characteristics: drain current as a function of gate-source voltage; typical values**



**Fig 7. Input and reverse transfer capacitances as a function of gate-source voltage; typical values**

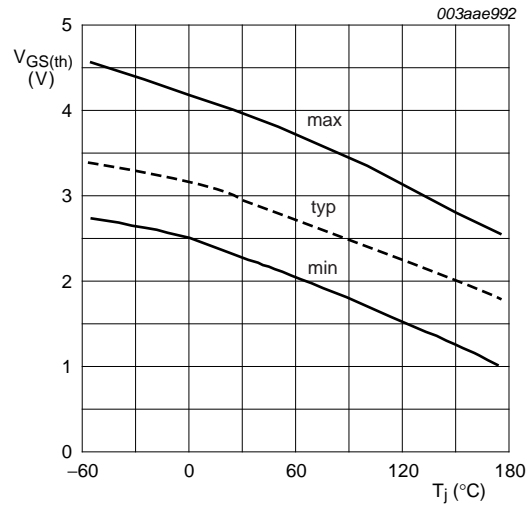


**Fig 8. Forward transconductance as a function of drain current; typical values**



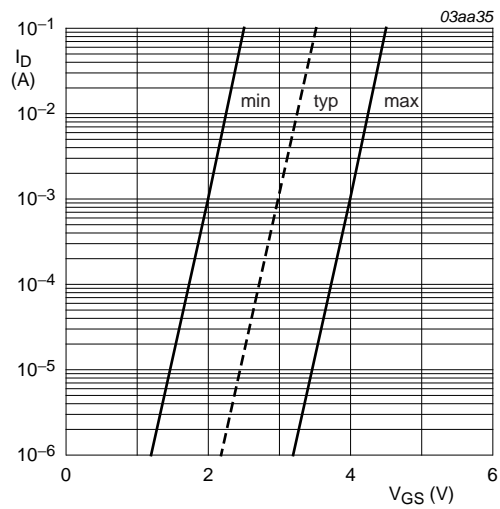

Fig 9. Drain-source on-state resistance as a function of gate-source voltage; typical values



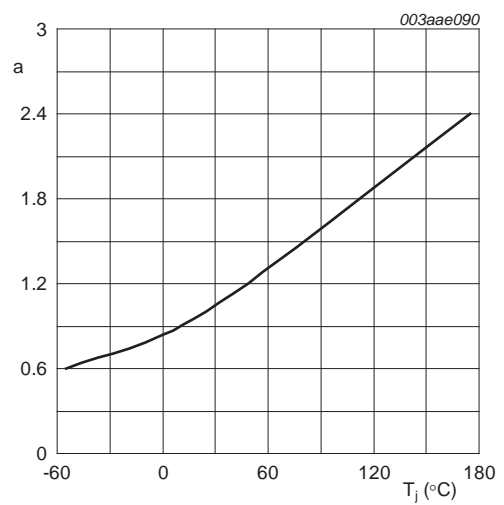

Fig 12. Normalized drain-source on-state resistance factor as a function of junction temperature

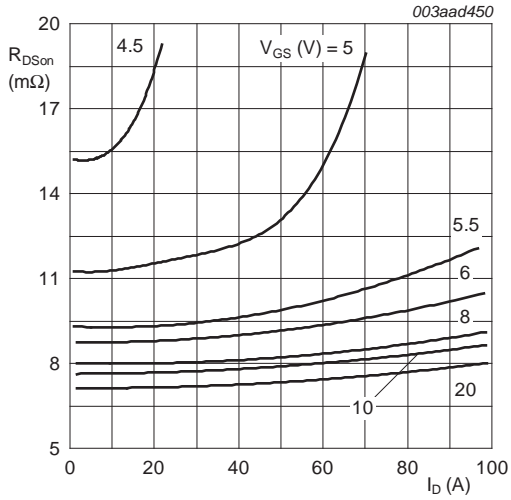


Fig 13. Drain-source on-state resistance as a function of drain current; typical values

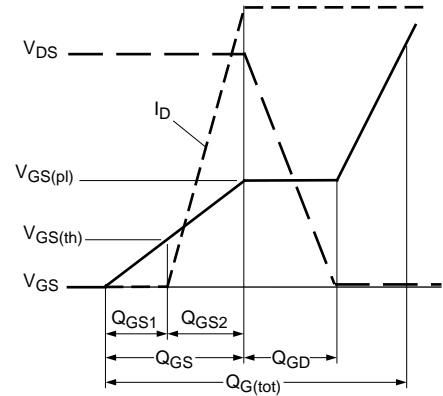


Fig 14. Gate charge waveform definitions

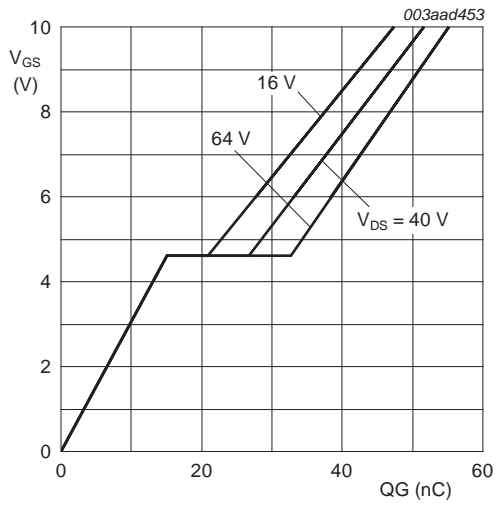


Fig 15. Gate-source voltage as a function of gate charge; typical values

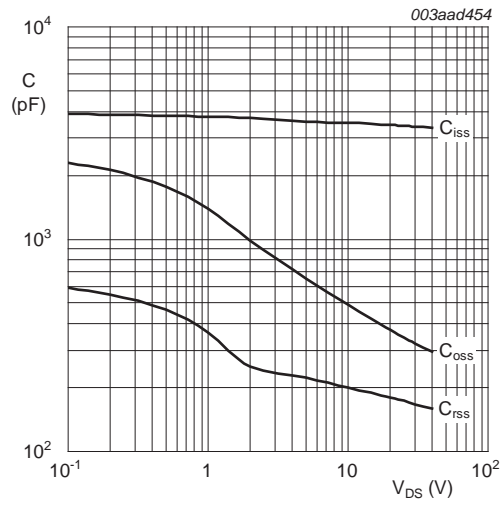


Fig 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values



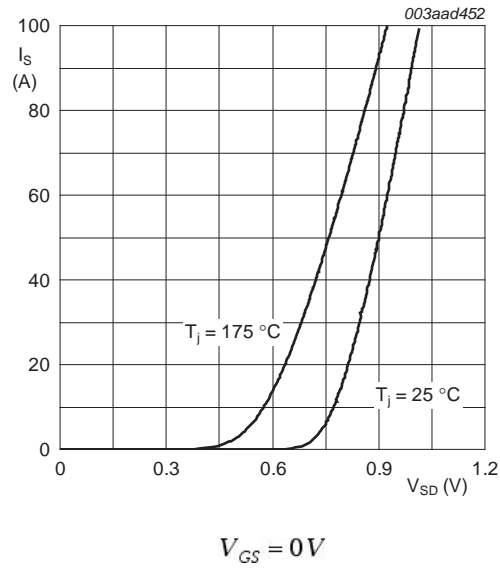


Fig 17. Source (diode forward) current as a function of source-drain (diode forward) voltage; typical values
