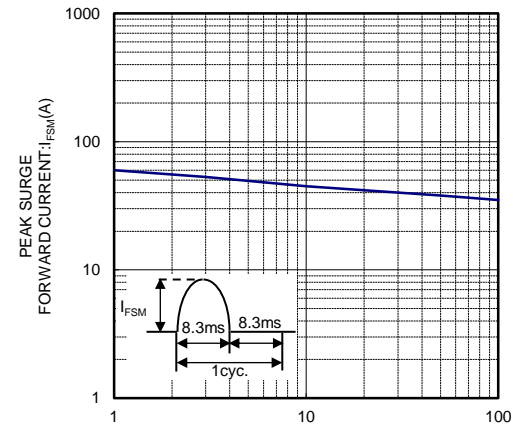




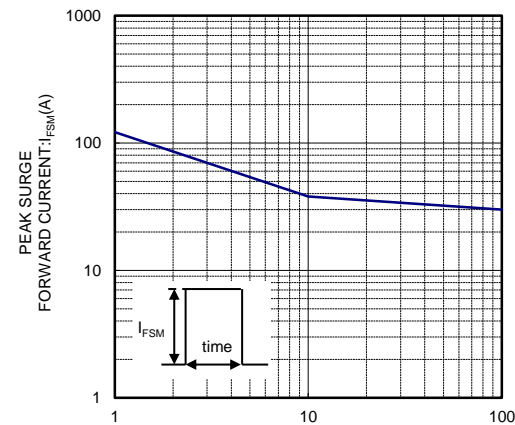
I_FSM DISPERSION MAP



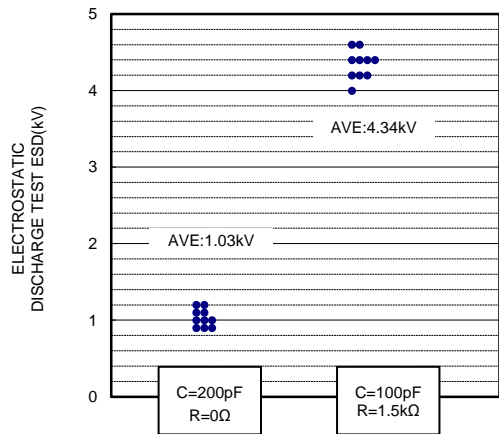
t_rr DISPERSION MAP



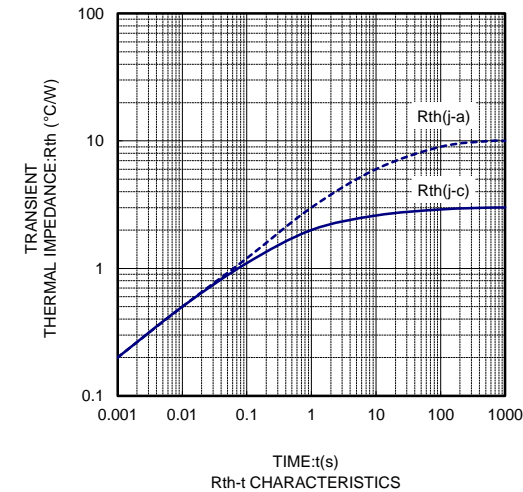
NUMBER OF CYCLES
I_FSM-CYCLE CHARACTERISTICS



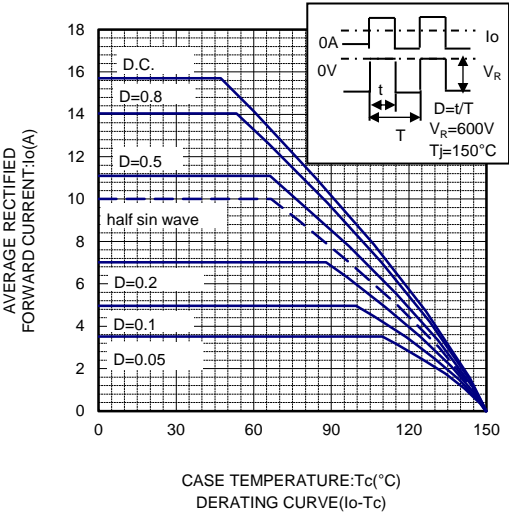
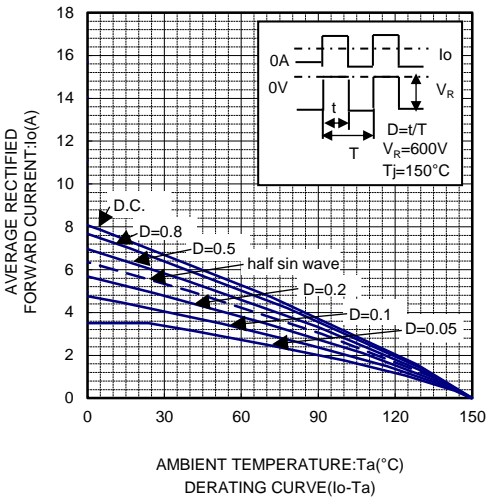
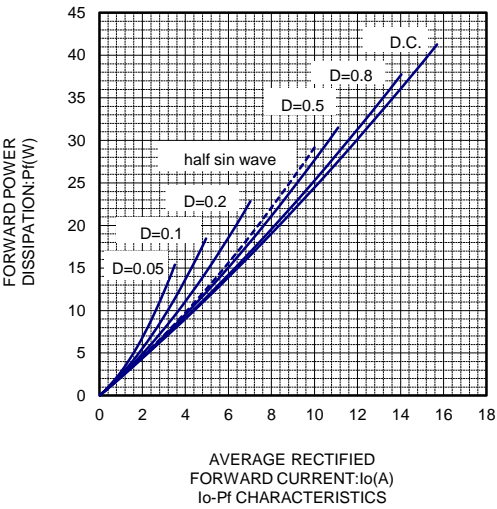
