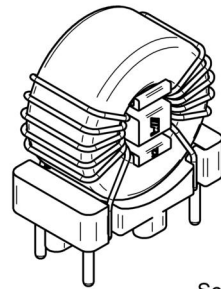

**F Typical Insertion Loss Characteristics:**



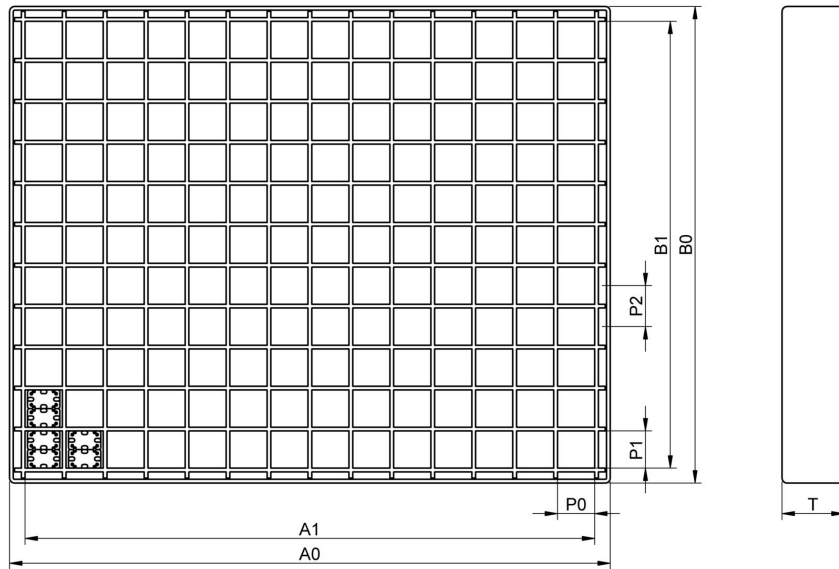

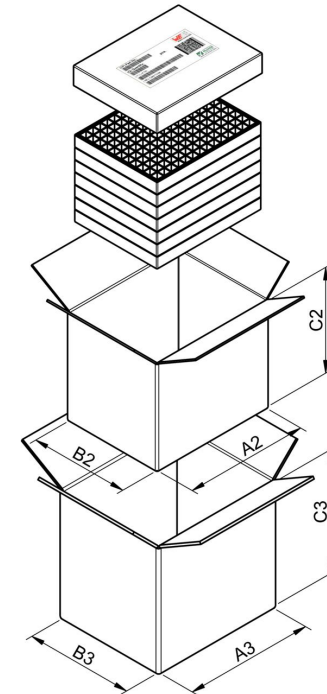


