




Fig. 5.1 Definitions of Electrical Characteristics








Fig. 8.1 I-V



9. Clamp Voltage V_C - Peak Pulse Current (I_{PP}) (Note)







Fig. 9.1 V_C - I_{PP}

10. ESD Clamp Waveform (Note)


