





### Fig.2 Grounded Emitter Output Characteristics






### Fig.4 DC Current Gain vs. Collector Current (II)





## Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current(I)






Fig.7 Base-Emitter Saturation Voltage vs. Collector Current (I)







Fig.8 Collector-emitter saturation voltage vs.collector current (II)





### • Electrical characteristic curves ( $T_a = 25^{\circ}C$ )






### Fig.10 Safe Operating Area




