## B Recommended land pattern: [mm]






# F3 Forward Current vs. Forward Voltage:





## **F4 Luminous Intensity vs. Forward Current:**





The bin is defined on intensity, chromaticity coordinate or wavelength and forward voltage. In order to ensure highest availability, the reel binning of standard deliveries can vary. A single bin cannot be ordered. Please contact us in advance, if you need a particular bin sorting before placing your order to clarify the lead time, MOQ and pricing.



#### Product specific:

Follow all instructions mentioned in the data sheet, especially:

- •The soldering profile has to be complied with according to the technical reflow/ or wave soldering specification, otherwise this will void the warranty.
- •All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.
