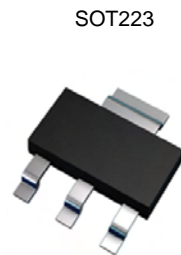

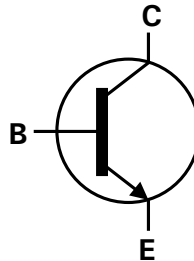

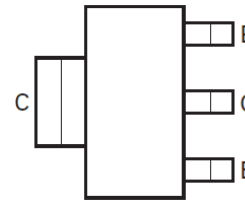

Device Symbol



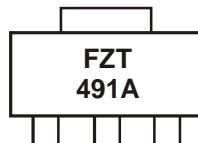

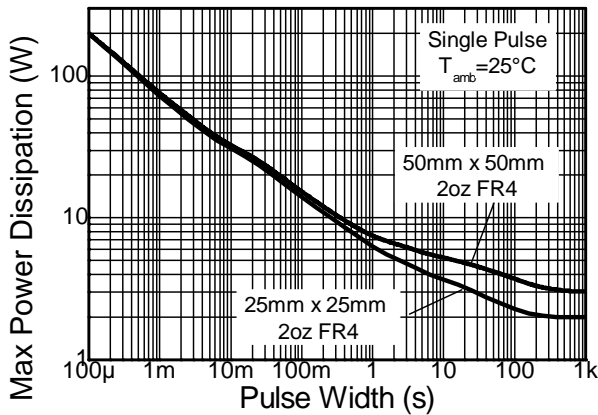

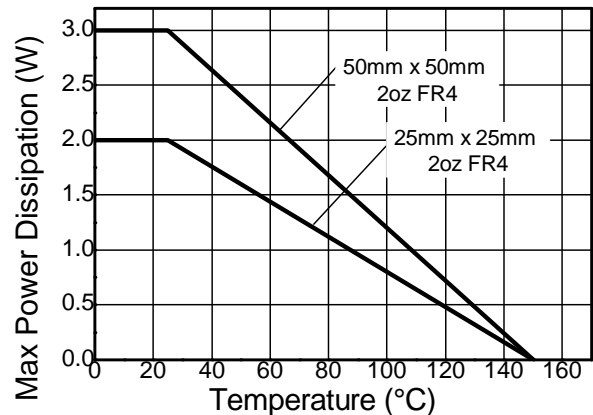
Transient Thermal Impedance

Pulse Power Dissipation



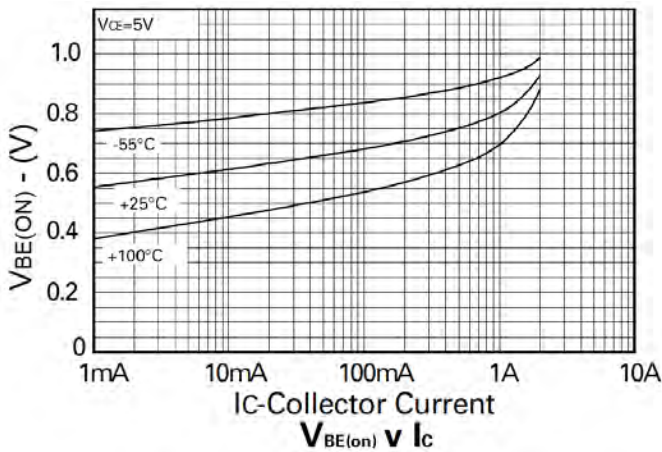
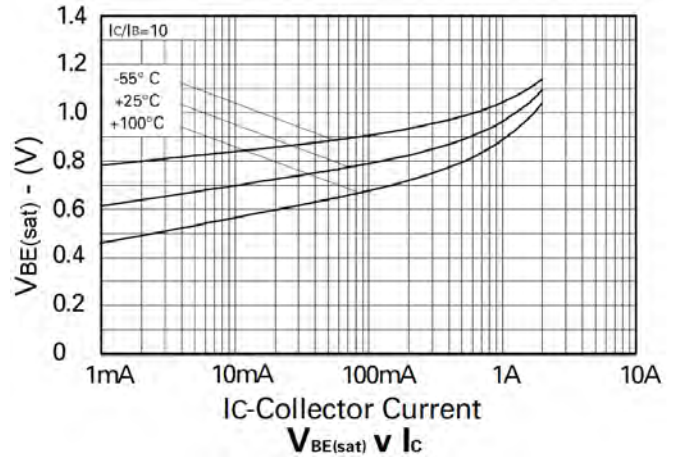
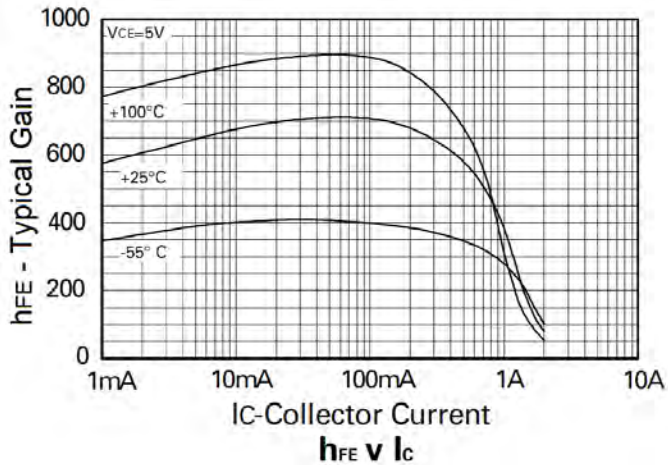
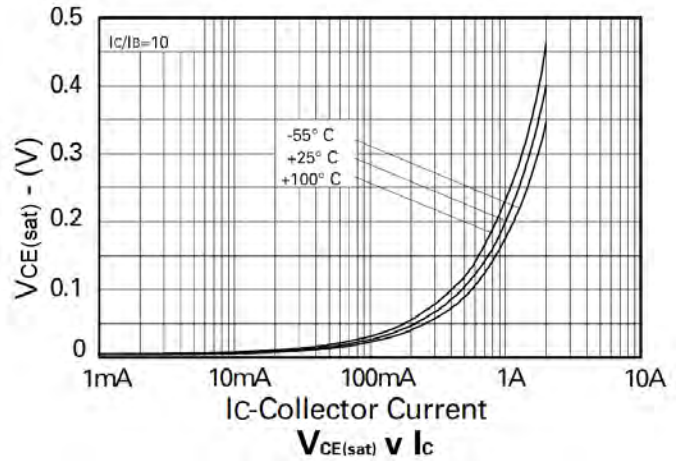
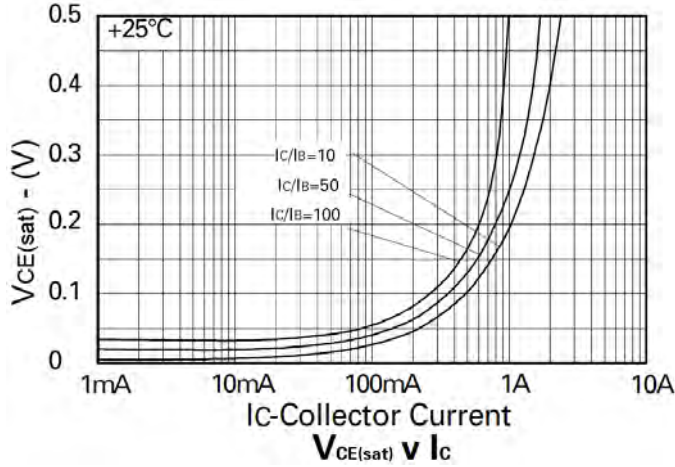

Package Outline Dimensions

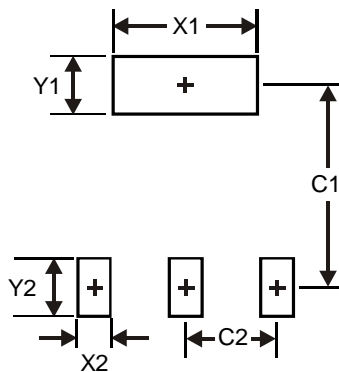
