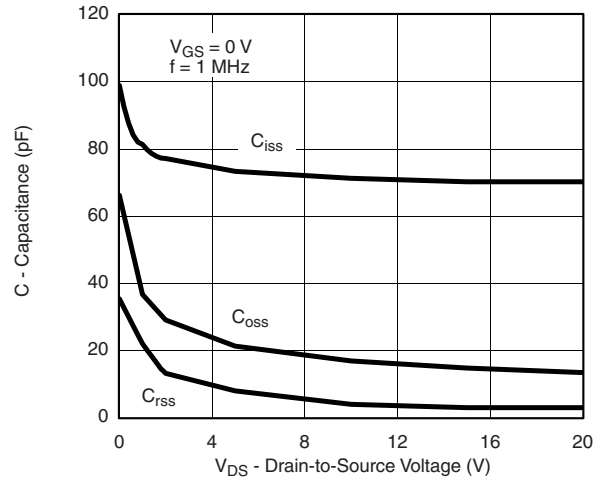

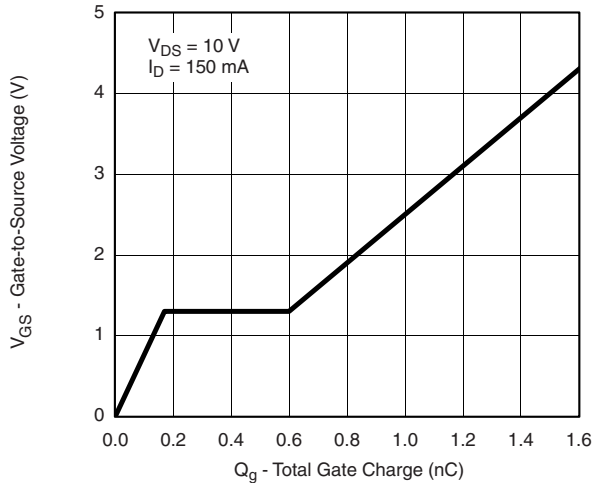

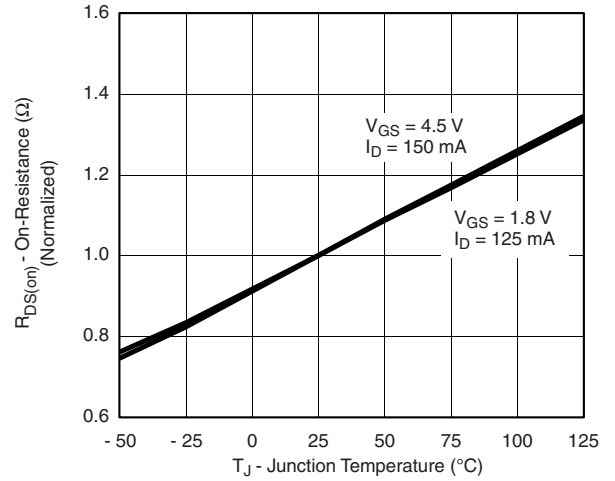
**On-Resistance vs. Drain Current**



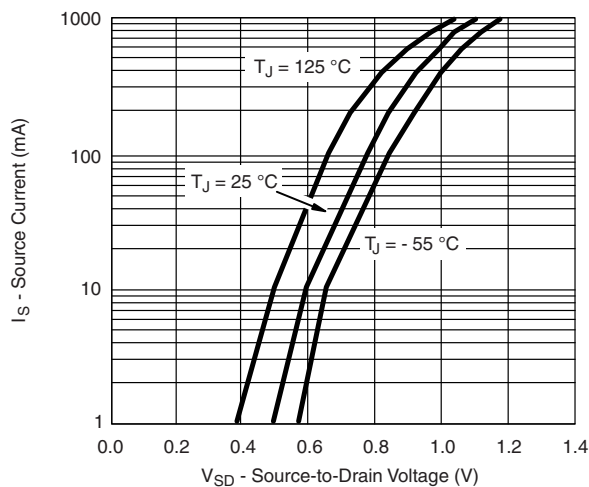
**Capacitance**



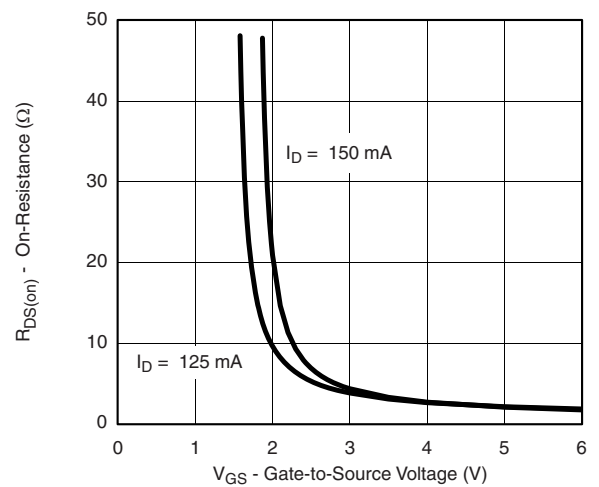
**Gate Charge**



**On-Resistance vs. Junction Temperature**

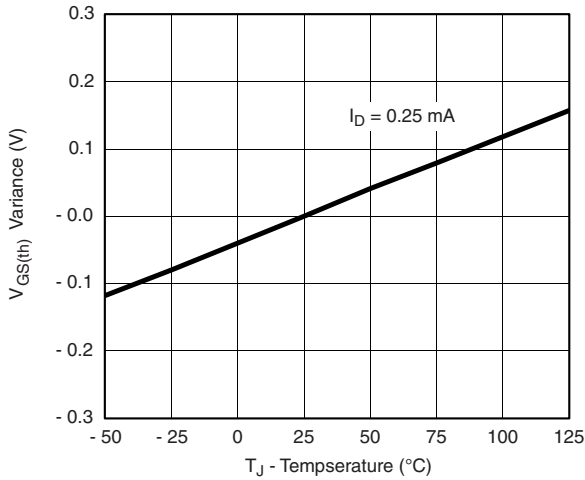


**Surge-Drain Diode Forward Voltage**

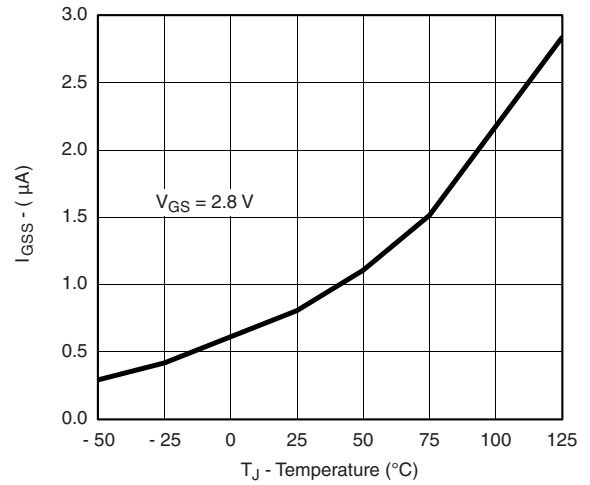


**On-Resistance vs. Gate-to-Source Voltage**

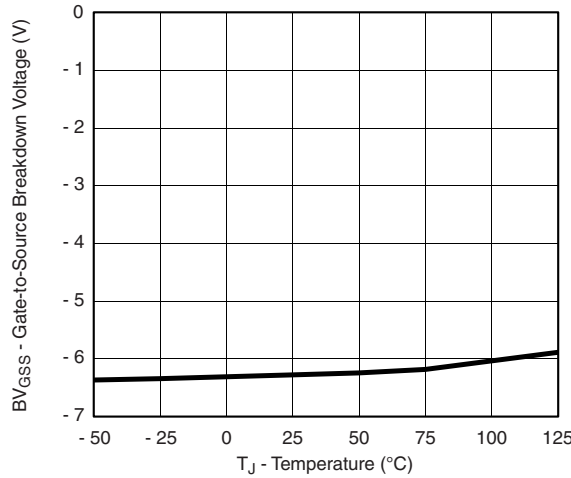

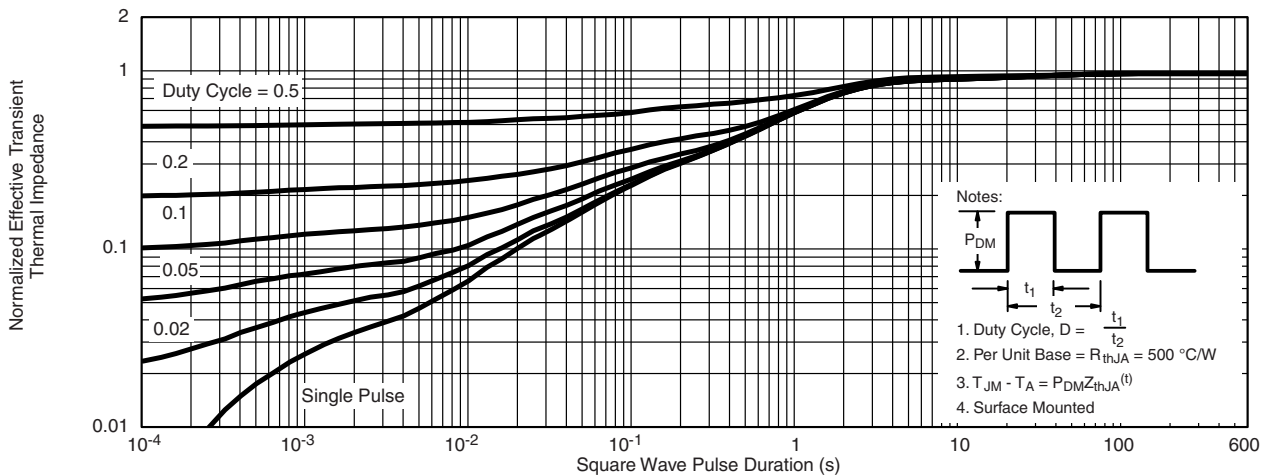
**Threshold Voltage Variance vs. Temperature**



**I<sub>GSS</sub> vs. Temperature**



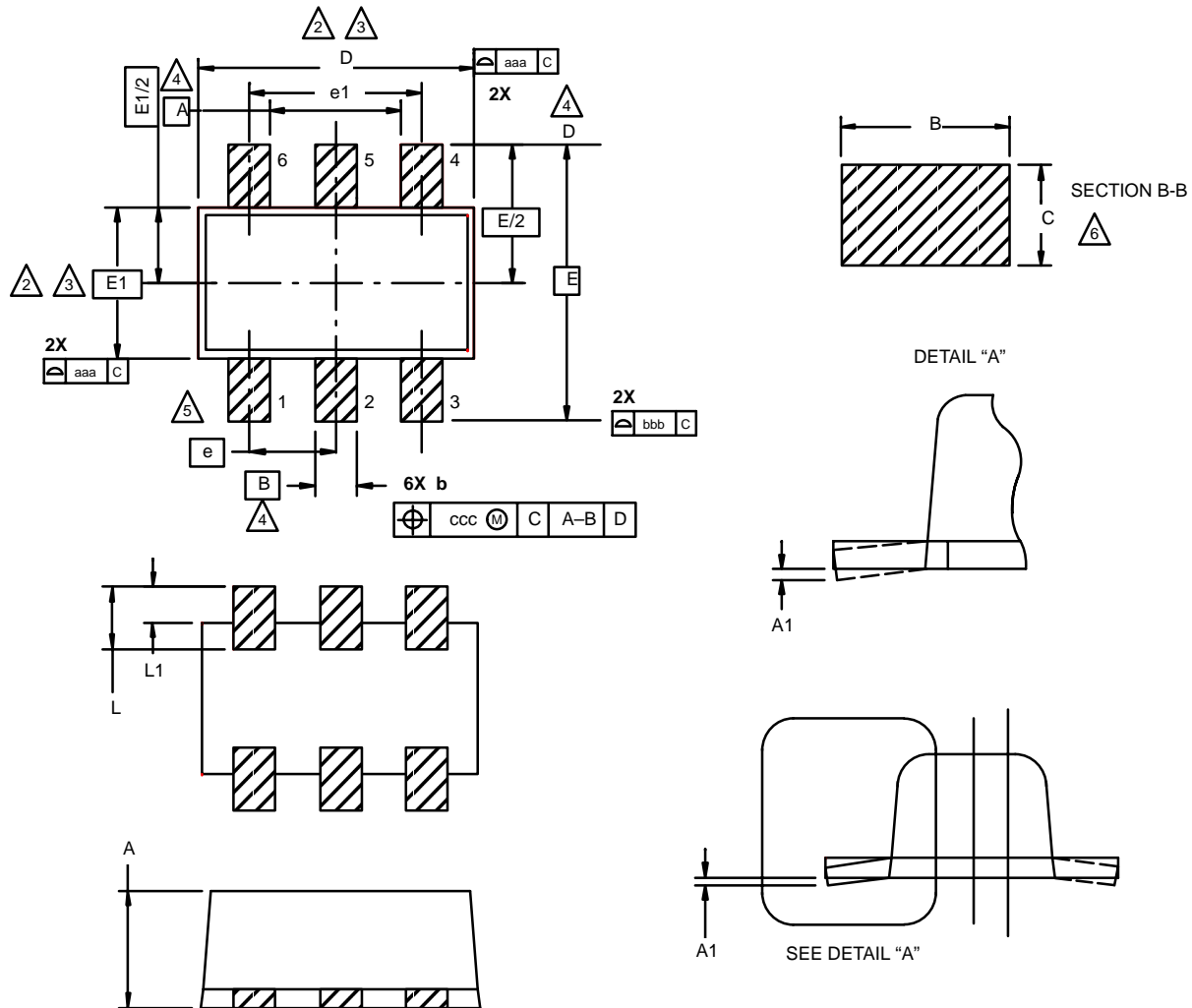
**BV<sub>GSS</sub> vs. Temperature**

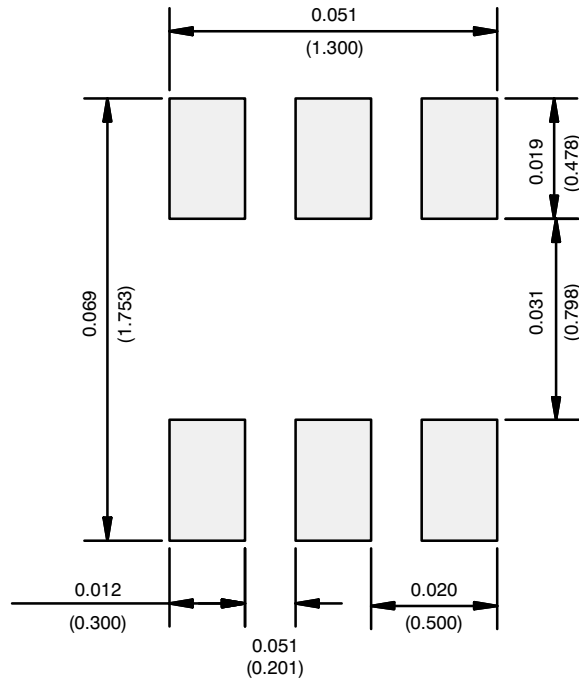
