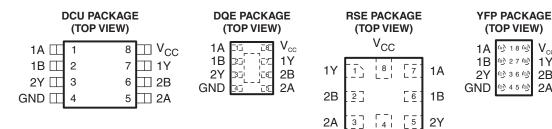

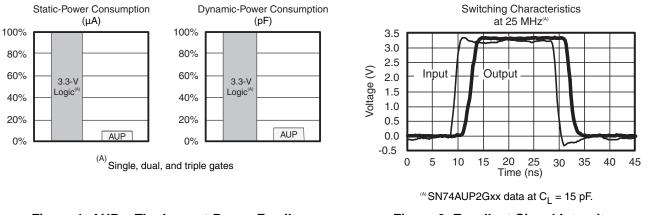




Figure 2. Excellent Signal Integrity

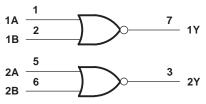

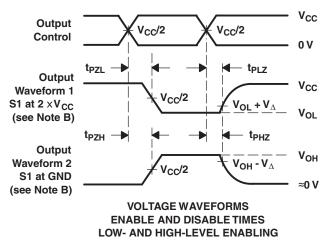

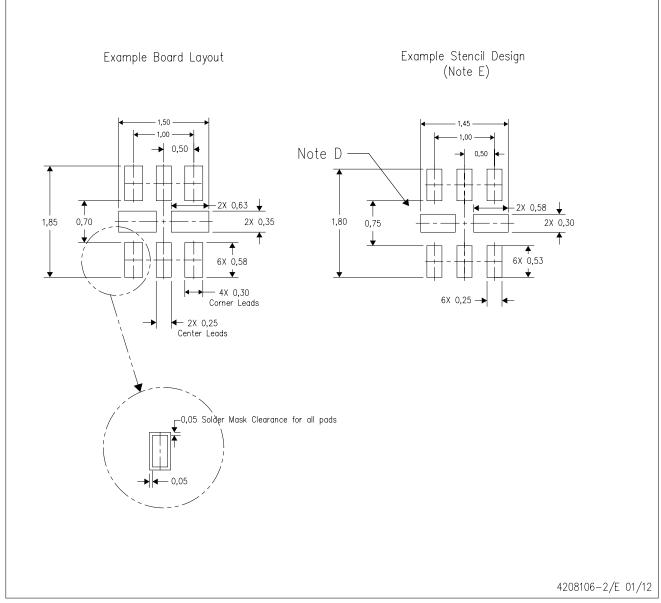

PLASTIC QUAD FLATPACK NO-LEAD

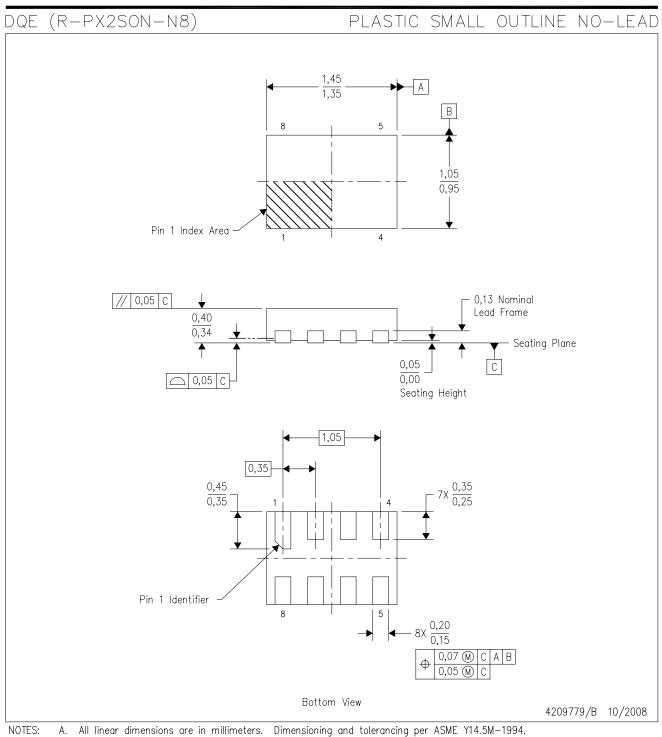

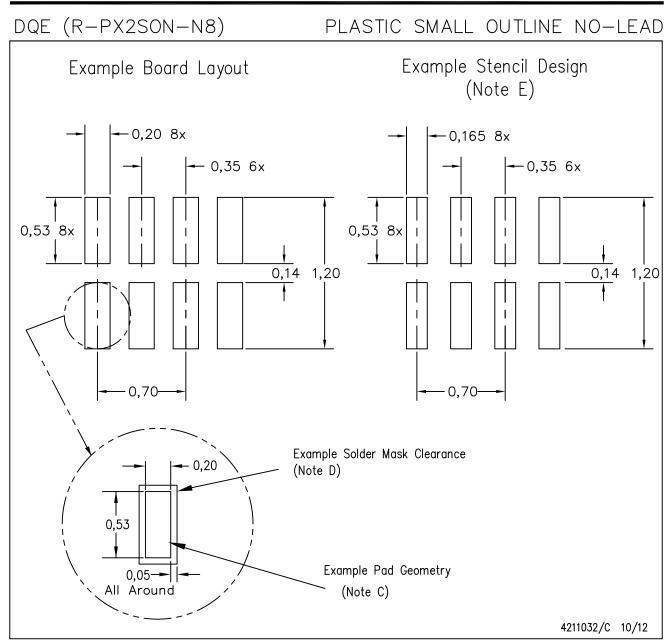

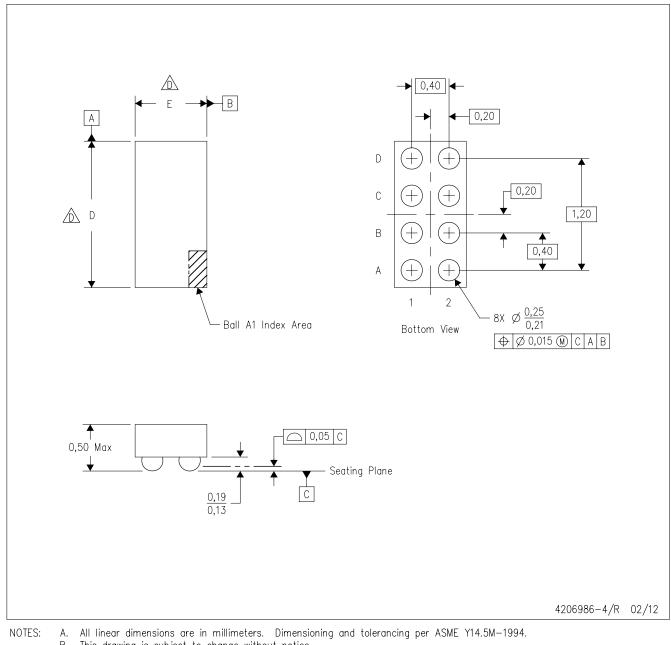
