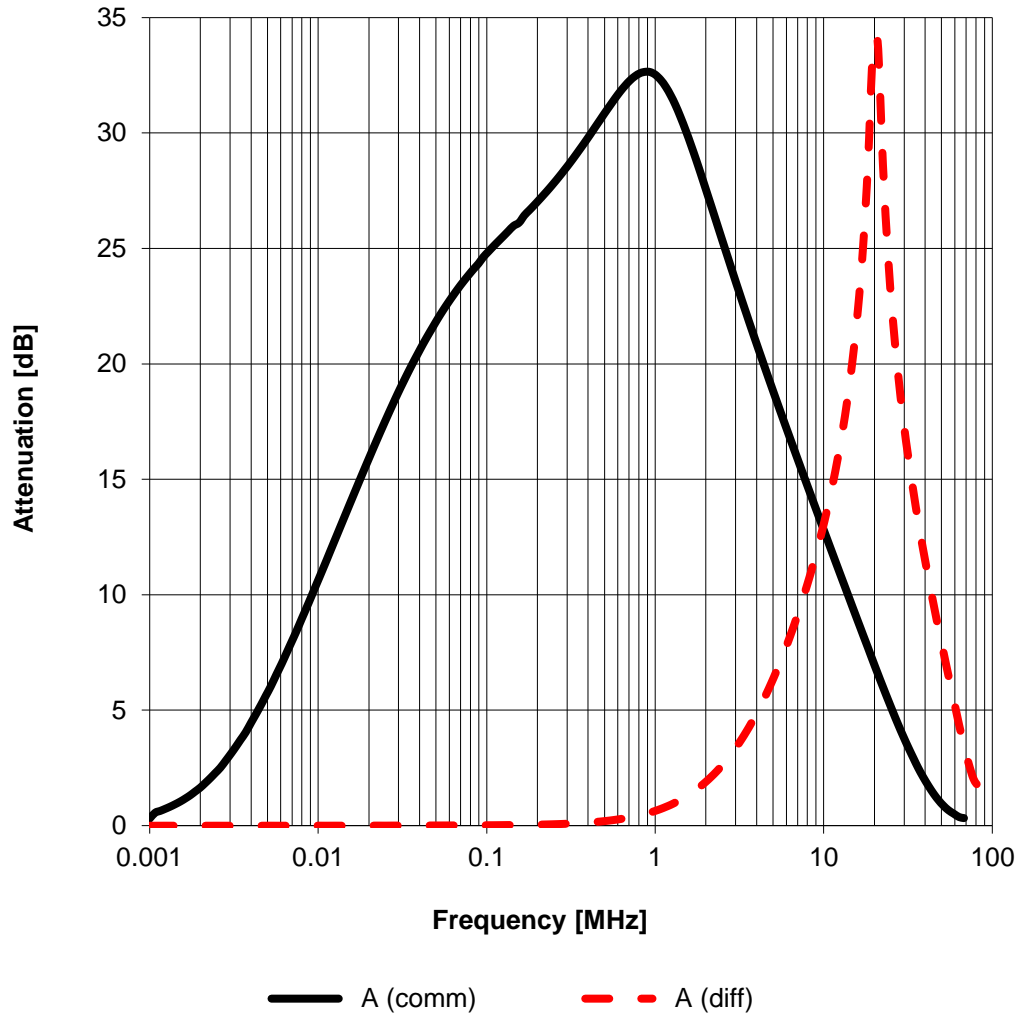





Differential Mode




