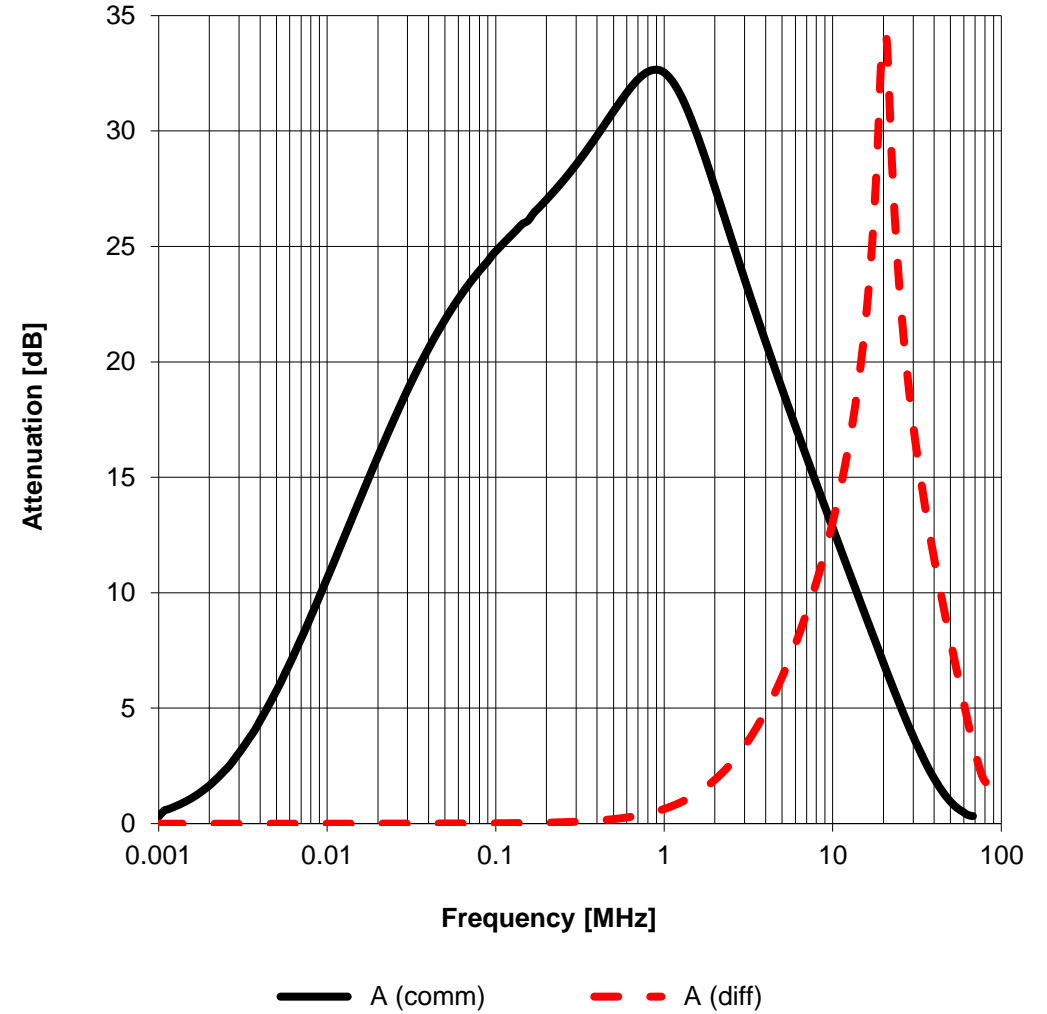
Common Mode






