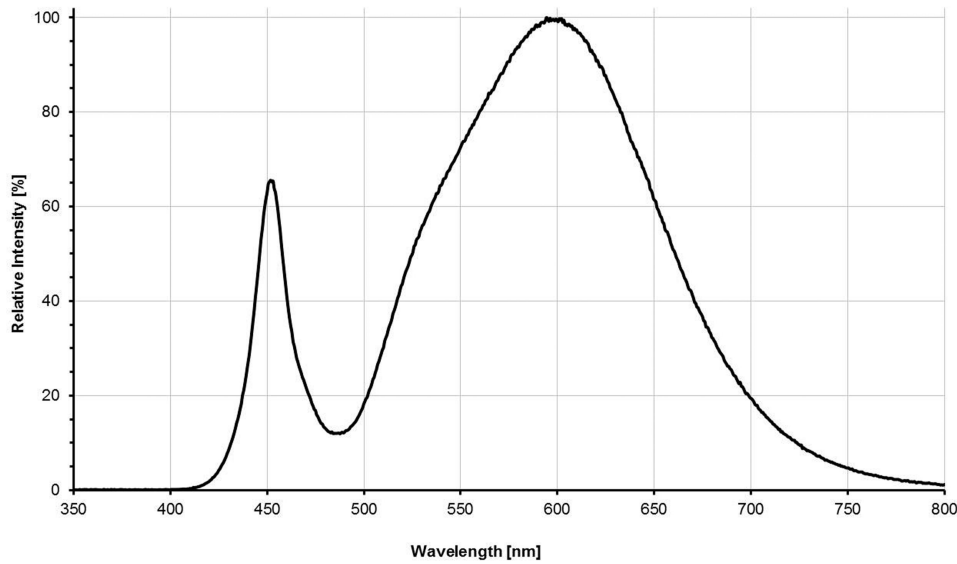

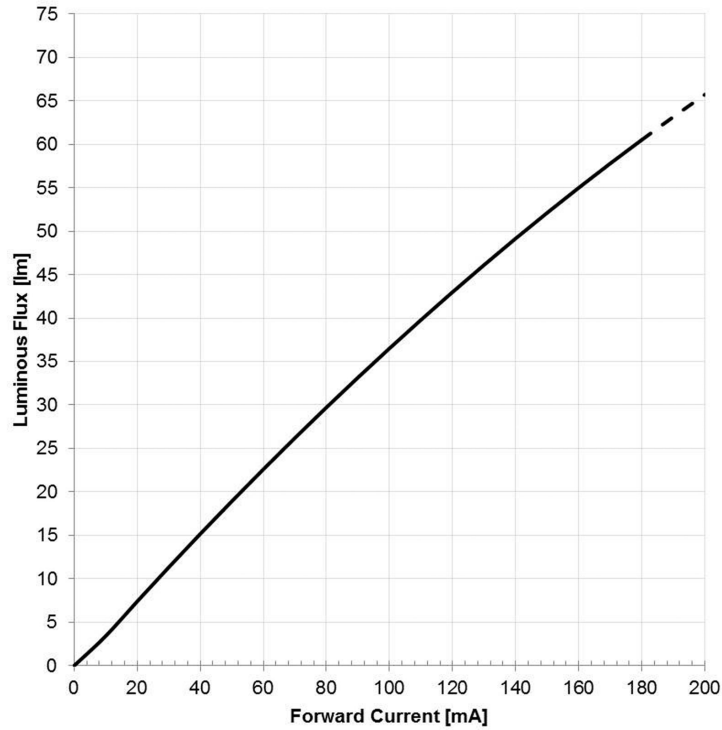

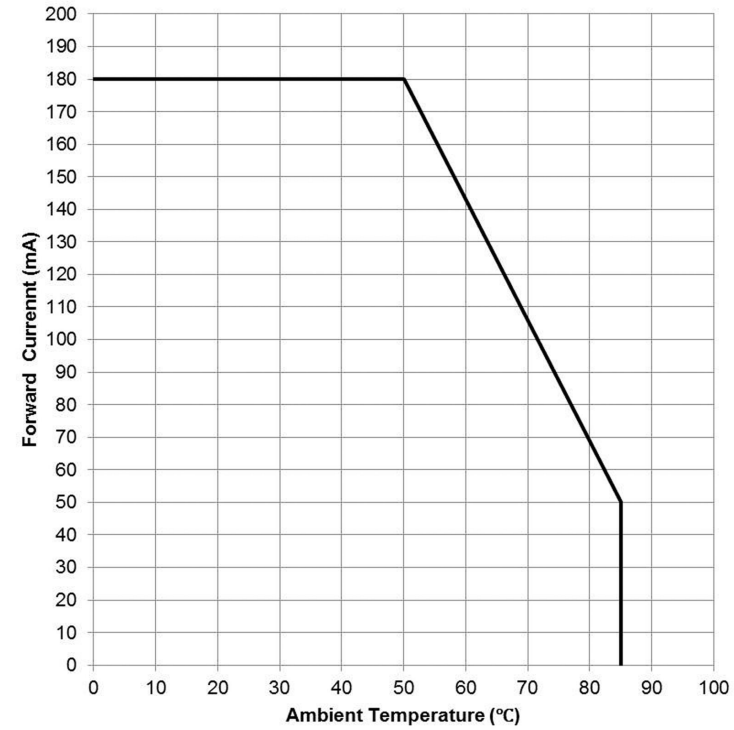

F5 Derating Curve:

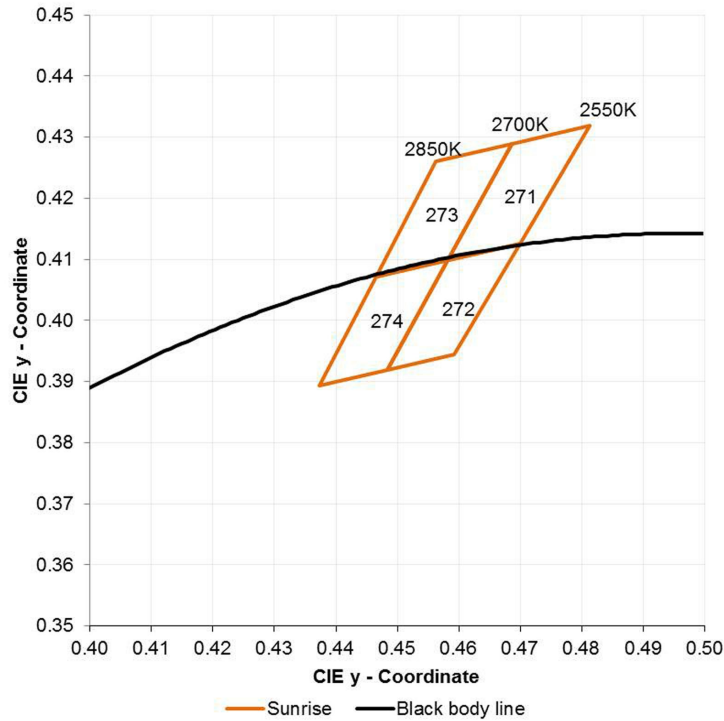

F6 Chromaticity diagram:



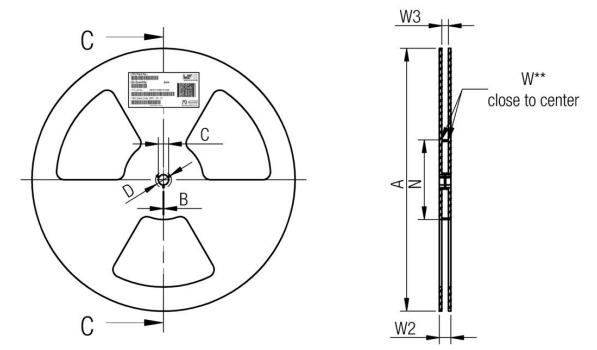

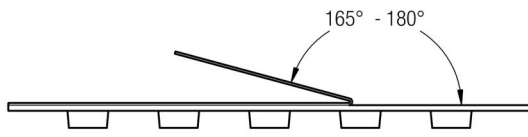
