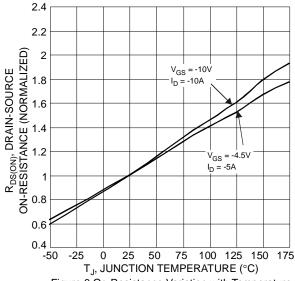
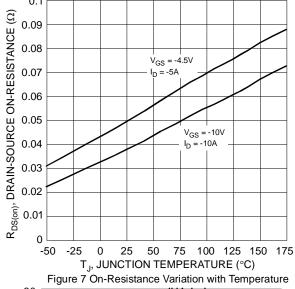
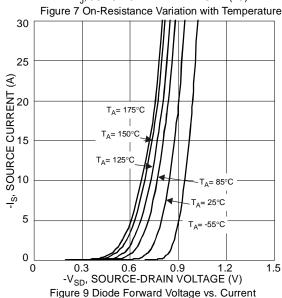
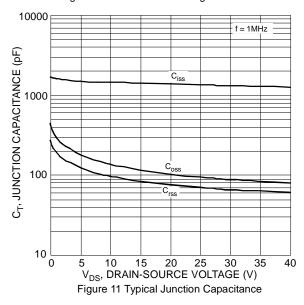


Figure 6 On-Resistance Variation with Temperature









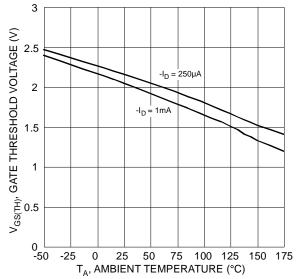


Figure 8 Gate Threshold Variation vs. Ambient Temperature

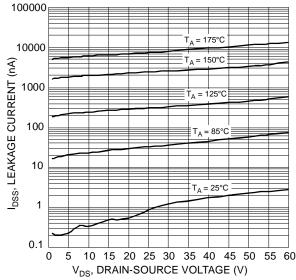
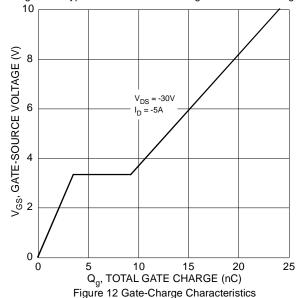
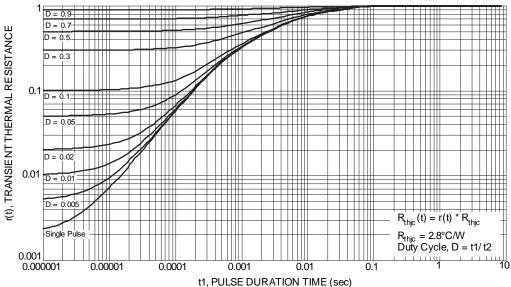
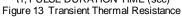


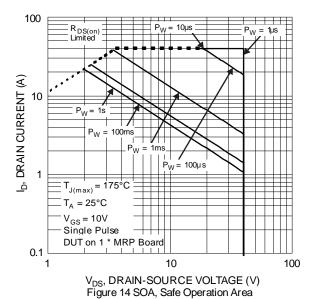
Figure 10 Typical Drain-Source Leakage Current vs. Voltage







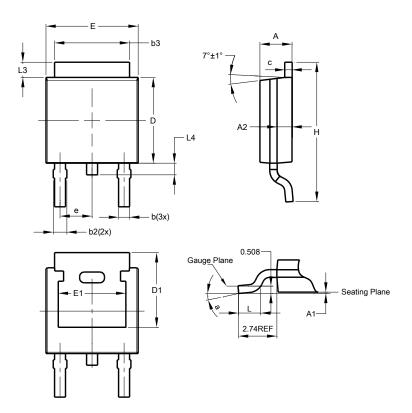

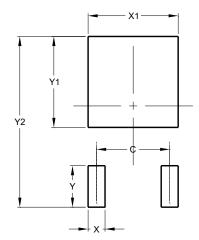
