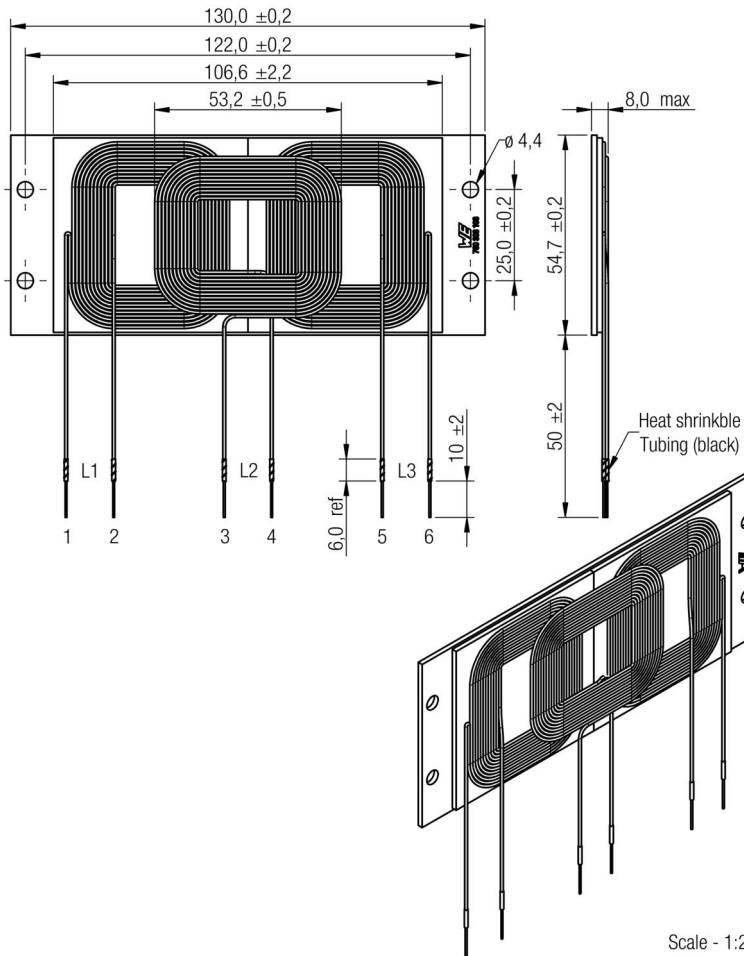
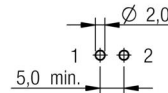

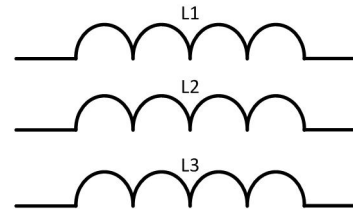


B Recommended hole pattern: [mm]

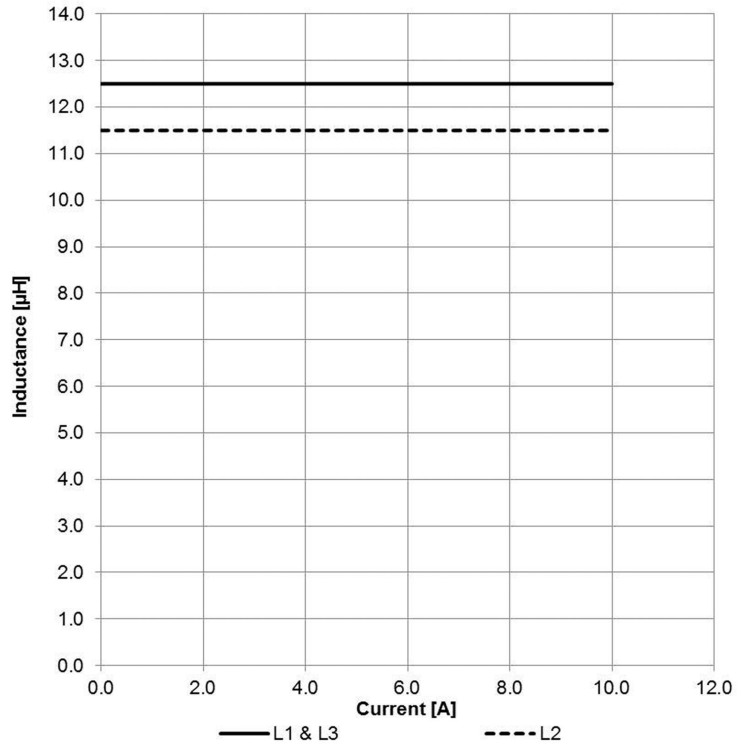

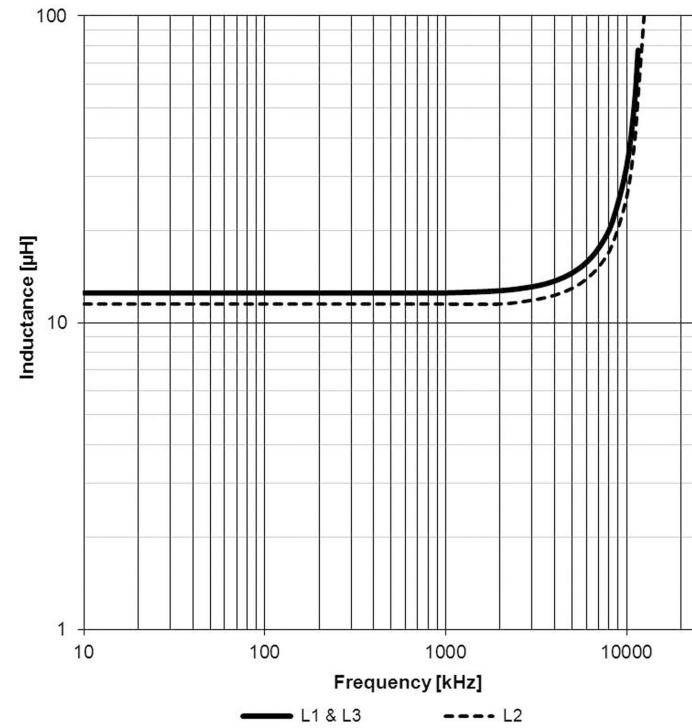

F Typical Inductance vs. Frequency Characteristics:

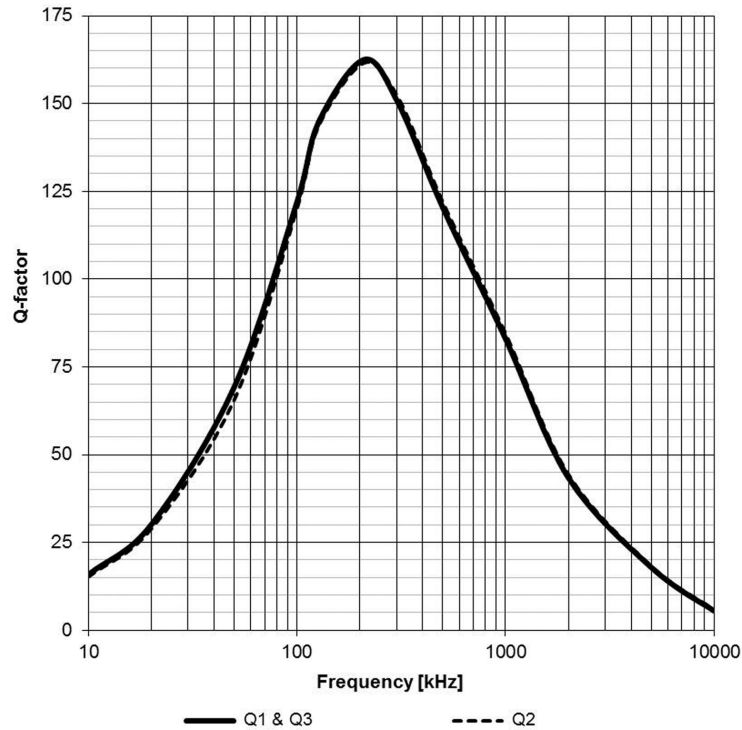



Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.
