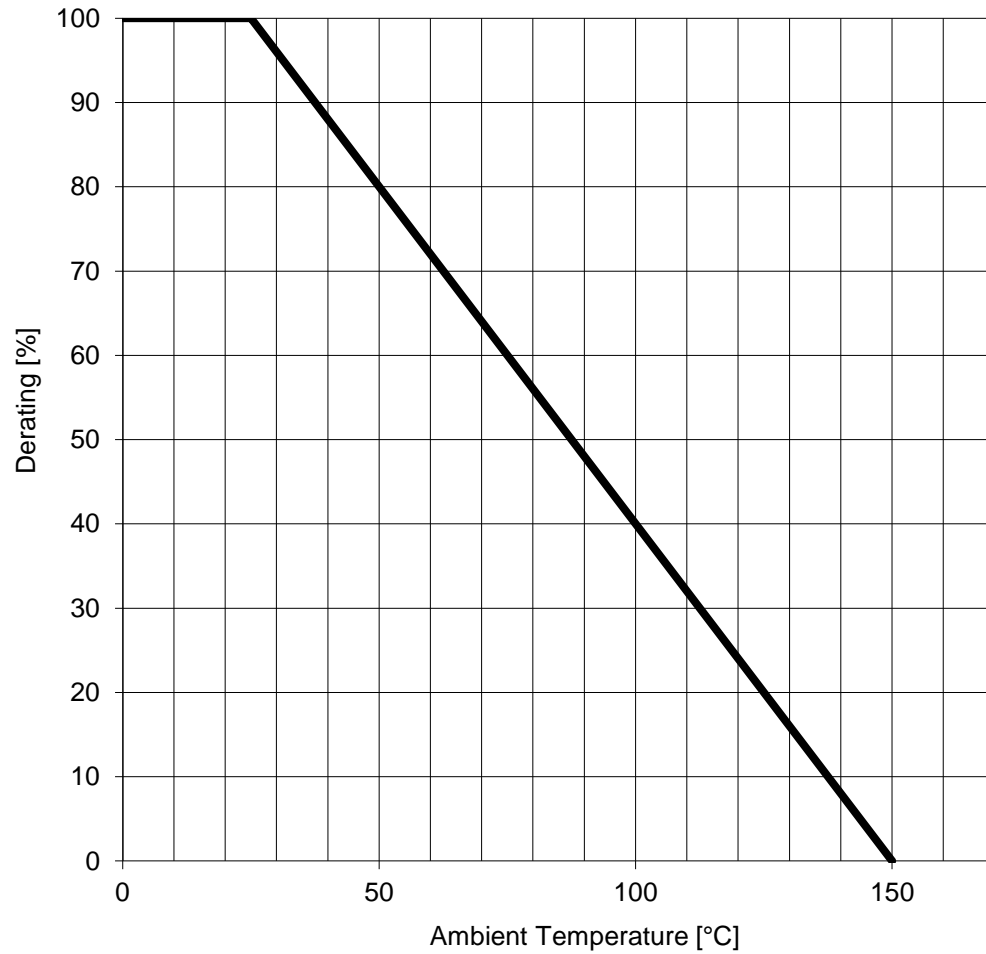
### Maximum Peak Pulse Power Rating



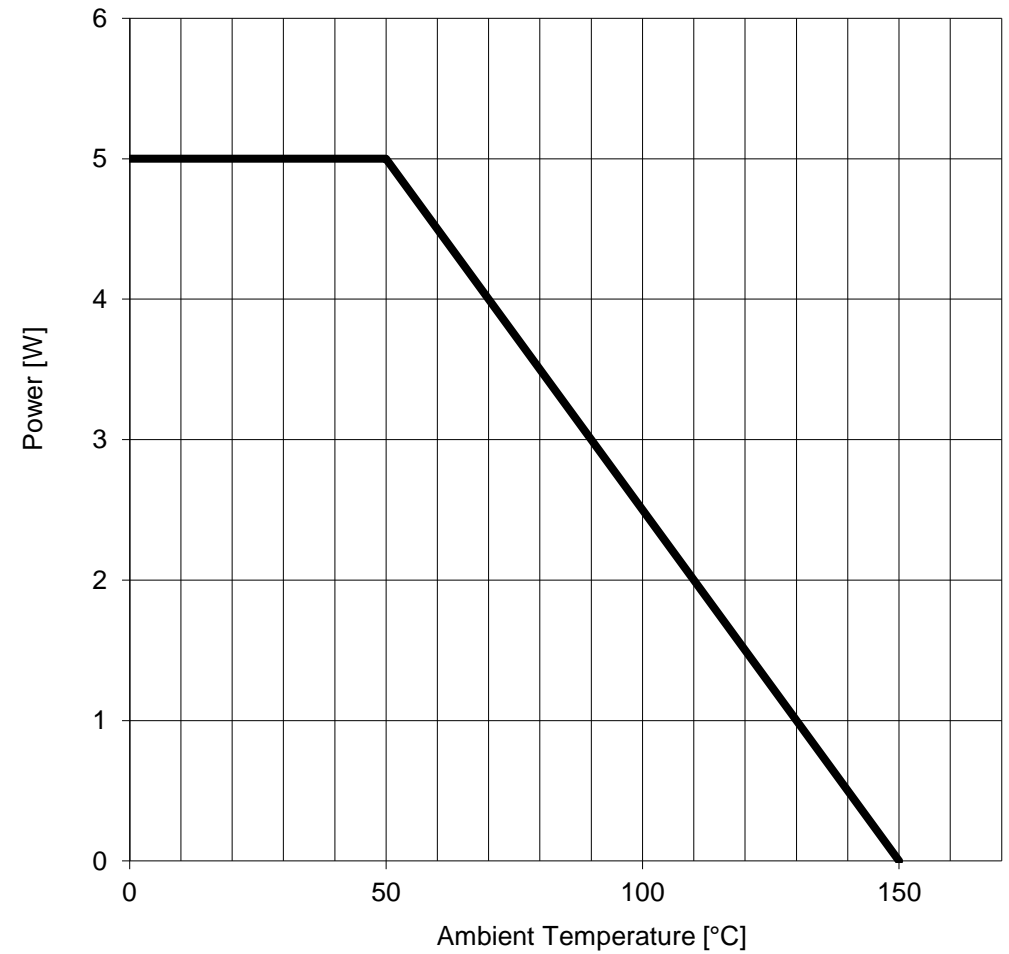

## Steady State Power Dissipation Derating



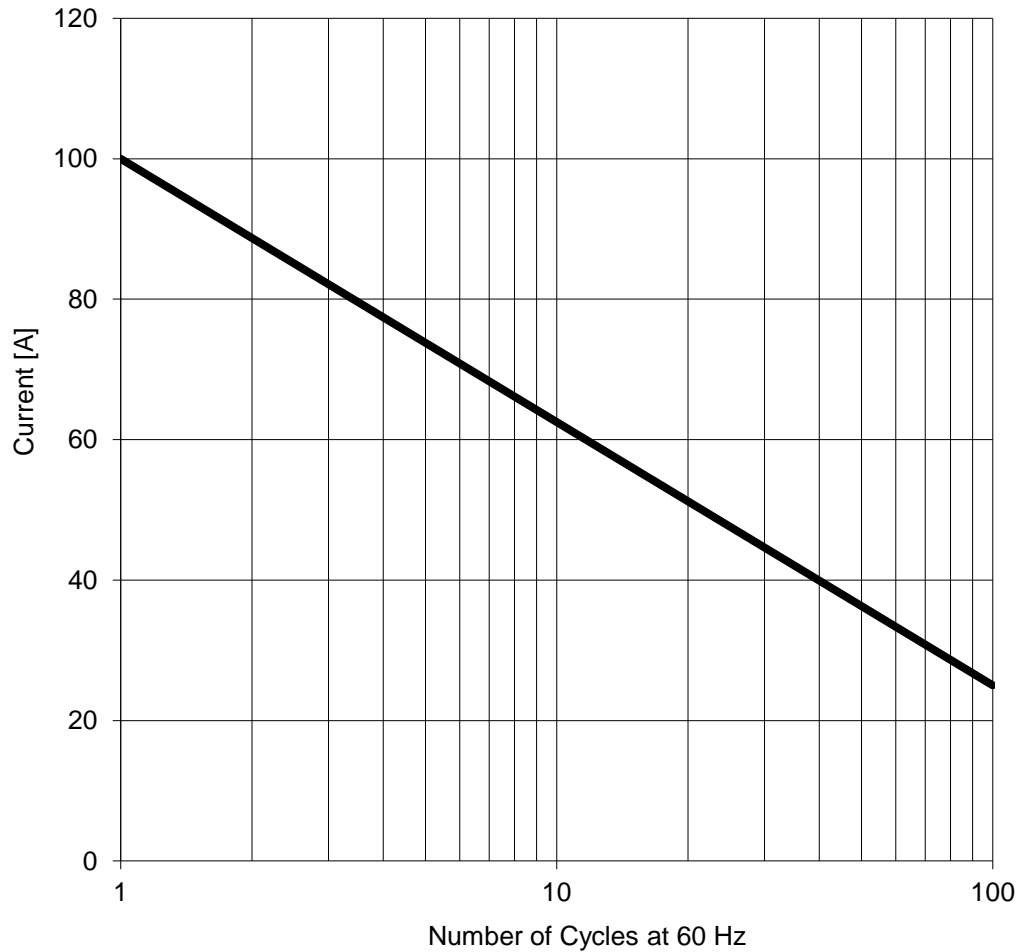

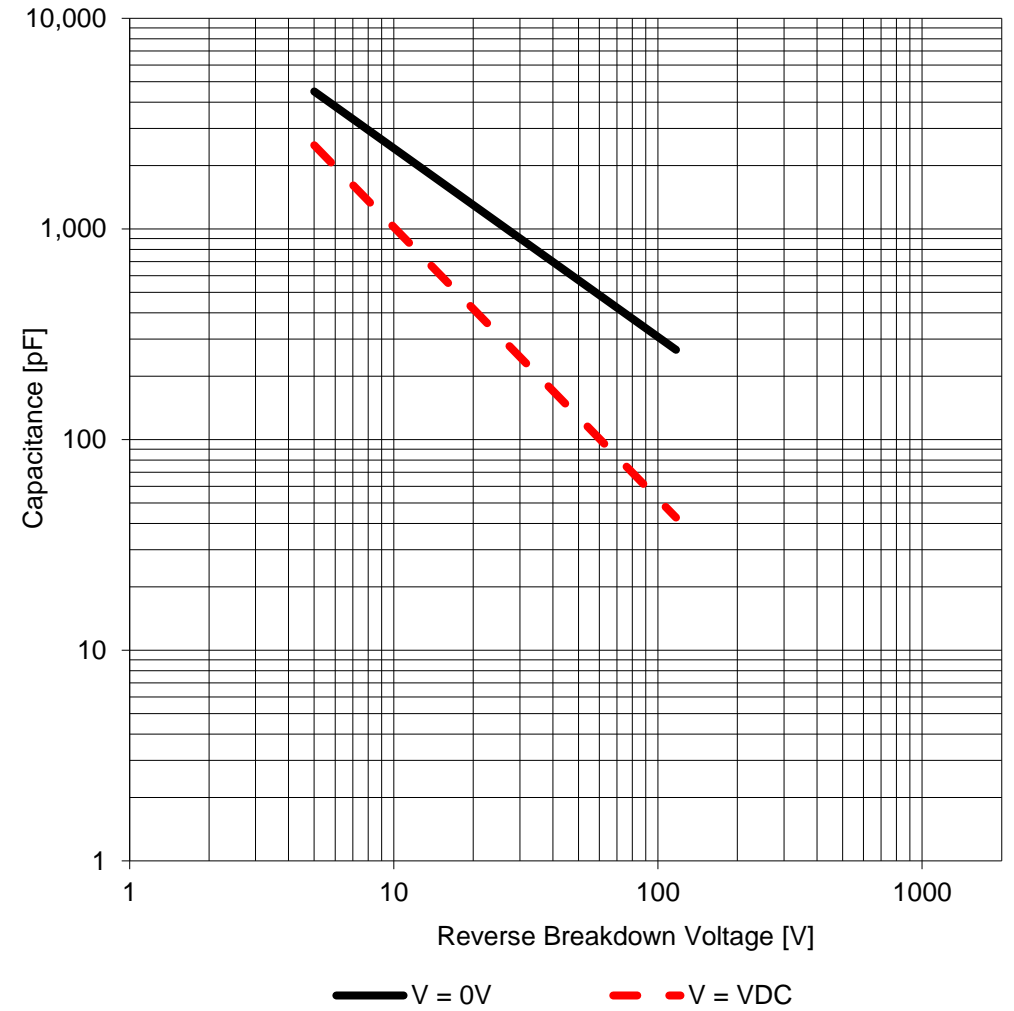

## Typical Junction Capacitance






